NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.(RRS) with AS prescriptions published by Australian Sailing
- 1.2 The AS Special Regulations – Part 2 for Off the Beach Boats will apply. Attention is drawn to Regulation 5.01 (LifeJackets).
- 1.3 The class rules of the Flying Ant Skiff Association will apply.

2 ADVERTISING

Boats may be required to display advertising chosen and supplied by the Organising Authority.

3 ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to boats of the Flying Ant Skiff class that have a current measurement certificate and are registered with the Flying Ant Skiff Association of Western Australia (Inc) (FASAWA).
- 3.2 Eligible competitors shall be a current member of a Australian Sailing affiliated yacht/sailing club and a financial member of FASAWA and provide an AS Number

4 FEES

The Entry fee is \$80 per boat is required by cob 9th of March. All sailors must be a member of the Flying Ant Skiff Association of WA to be eligible for entry. Please contact the Treasurer if you require Association membership.

5 SCHEDULE

5.1 Competitor Briefing – Saturday 16th March 2019 at 08:00.

5.2 Racing:

Maximum of 9 races.

Day	Date	First Warning Signal
Saturday	16th March	09:30
Sunday	17th March	09:30

No warning signal will be made after 16:00 on the last day of racing.

5.3 FASAWA AGM – Sunday 17th March 2019 at 12:00.

5.4 Presentations – Sunday 17th March 2019 as soon as possible after racing.

6 MEASUREMENTS

6.1 Boats measured since 1 July 2016 need not be re-measured. Other boats will need to be measured. Measurement will be in accordance the Flying Ant Skiff Association class rules. Please contact FASAWA to arrange measurement if required.

6.2 Only one set of equipment shall be used. Changes to equipment shall only be made with the approval of the Race Committee in compliance with the Sailing Instructions

7 SAILING INSTRUCTIONS

The Sailing Instructions will be available no later than 08:00 on Saturday 16th March 2019 at TCYC.

8 VENUE

8.1 Sailing will be conducted from TCYC, Magles Bay W.A.

8.2 Racing area will be in the vicinity of TCYC, on Cockburn Sound.

9 THE COURSES

The courses will be "windward-leeward-triangular" as described in the Sailing Instructions.

10 SCORING

10.1 A total of nine races will be sailed with a minimum of four (4) races required to be completed to constitute a series.

10.2 (a) When fewer than five (5) races have been completed, a boat's series score will be the total of her race scores.

(b) When from five (5) to eight (8) races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

(c) When nine (9) races have been completed, a boat's series score will be the total of her race scores excluding her worst two scores.

11 PRIZES

Prizes will be given as follows:

- First to third place Overall
- First to third on Handicap
- First Place unconvrted Ant

Other prizes may be awarded at the discretion of the Organising Authority.

12 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

13 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of AUD\$10,000,000. Competitors may be required to provide evidence of adequate insurance to the Organising Authority.
