The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

#### 1. Rules

- 1.1 The regatta will be governed by the rules as defined in:
  - (a) The Racing Rules of Sailing (RRS).
  - (b) The IRC rules, Parts 1, 2 and 3.
  - (c) The Australian Sports Boat Association rules (ASBA).
  - (d) The Class Rules of individual classes of boats shall apply.
  - (e) The feeder race and the short and long passage races are classed as Category 6, as defined in Section 2 of the Australian Sailing Special Regulations Part 1.
  - (f) Appendix T Arbitration shall apply.
  - (g) Premier Cruising Multihull SSIs shall Apply
  - (h) Supplementary sailing instructions (SSI) may be issued for classes holding State or National Championships
  - (i) The racing will be conducted in accordance with Federal and State legislations relating to COVID-19. Competitors are responsible for deciding whether to participate or not, and for compliance with all applicable rules and regulations, including all COVID regulations
- 1.2 The following racing rules (RRS) are modified in accordance with RRS 86 as follows:
  - (a) RRS 77, Identification on Sails. A boat without identification numbers on the main, headsail and spinnaker shall display bow numbers on each side of the bow no more than one metre from the bow for the duration of the event. Numbers will be available at registration.
  - (b) RRS 44.1- Taking a Penalty is changed for all Divisions so that the Two-Turns penalty is replaced by the One-Turn penalty.
  - (c) RRS 49, Crew Position; Lifelines, RRS 55 Setting and Sheeting Sails and RRS 51 Movable Ballast, will apply except that:
    - (i) Boats complying in all respect with the requirements of their particular class rules may race wholly within the rules of that class unless otherwise prescribed in the sailing instructions, and
    - (ii) Boats not racing to class rules, but whose design incorporates fixed or retractable bow sprit, outriggers, trapezes or equipment to move water as ballast, may use such devices and features.

## 2. Event Advertising

2.1 Boats may be required to display advertising chosen and supplied by the Organising Authority.

## 3. Eligibility and Entry

- 3.1 This regatta is open to all Monohull and Multihull Sailing craft
- 3.2 Eligible boats may enter online via the TCYC website www.tcyc.com.au, or by completing the attached form which is also available on the website or at the club, and sending it, together with the required fee, to the club no later than 12th December 2022
- 3.3 Late entries will only be accepted at the discretion of the race committee.

- 4.1 The following restrictions on the number of boats apply:
  - (a) If, by the closing date, less than 5 entries are received in any division, the OA may change the eligibility requirements, cancel that division or re-allocate yachts to other divisions.
  - (b) Yachts affected will have the option of confirming their entry under the new eligibility requirement, transferring to another division (if eligible) for no additional fee, or having their fee refunded.
  - (c) Where there are sufficient entries the OA may at its discretion divide any division into further subdivisions.
  - (d) The OA shall have the right, in the interest of fair sailing, to allocate a yacht to a particular division.

#### 5. Fees

5.1 Fees shall be \$295 for the entire regatta. The \$295 fee includes two (2) Smorgasbord dinners.





#### 6. Schedule

6.1 Detailed race schedules and courses will be described in the Sailing Instructions.

- 6.2 Racing for Premier Cruising, Jib and Main (JAM), Multihull and Classic will be a combination of, Around the Buoys races and Passage races in Cockburn Sound, with up to two races per day.
- 6.3 Racing for Divisions 1,2,3 and Sports Boats will be as per 6.2. In addition, up to five Windward/Leeward races may be scheduled.

## 7. Sailing Instructions

- 7.1 The Sailing Instructions will be available on The Cruising Yacht Clubs website www.tcyc.com.au under CSR no later than 30th November 2022.
- 7.2 Printed copies will be part of the event program included in the Skipper's Pack and may be obtained at registration.

#### 8. Communication

- 8.1 Notices to competitors will be posted on the official notice board located on the ground floor of the TCYC clubhouse
- 8.2 [DP] The regatta radio communications will be conducted on channel VHF 72.
- 8.3 [DP] Except in an emergency a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile phones.
- 8.4 All boats that are able should maintain a listening watch on the above allocated frequency.

### 9. Regatta Venue

- 9.1 The Cruising Yacht Club of Western Australia Inc., 2 Val Street, Rockingham WA.
- 9.2 The racing area will be on the waters of Mangles Bay and Cockburn Sound.

#### 10. Courses

10.1 Courses to be sailed will be Around the Buoys and Passage races using fixed marks and a day buoy, and Windward/Leeward courses as detailed in the Sailing Instructions.





### 11. Penalty System

- 11.1 RRS 44.1 is changed so that the two-turns penalty is replaced by the one-turn penalty.
- 11.2 Appendix T Arbitration shall apply.

### 12. Scoring

- 12.1 The Low Points scoring system of RRS Appendix A will apply.
- 12.2 Three (3) races are required to be completed to constitute a series.
- 12.3 When fewer than five races have been completed, a boat's series score will be the total of her race scores.
- 12.4 When from five (5) to eight (8) races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 12.5 When nine (9) or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.
- 12.6 The Cockburn Sound Regatta Overall Champion will be the boat with the lowest score calculated by dividing each boats PBH series score by the sum of the number of starters in each race. All races are to count for the purpose of this calculation.

## 13. Support Boats (DP)

13.1 Support Boats shall fly the TCYC club burgee and be marked with white and green flags.

## 14. Berthing (DP)

14.1 Boats shall be kept in their assigned places whilst they are in the mooring area.

## **15. Radio Communications (DP)**

15.1 The regatta radio communications will be conducted on VHF channels as detailed in the Sailing Instructions. Except in an emergency a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile phones.

## **16. CSR Trophies and Pennants**

- 16.1 Pennants will be awarded for 1st, 2nd and 3rd places each day for each of a division's races for PBH Handicaps.
- 16.2 Pennants will be awarded for 1st place each day for each of a division's races for IRC Handicaps.
- 16.3 Trophies will be awarded to the overall regatta 1st, 2nd and 3rd places for each division for PBH Handicaps. 5 entries are required for a division to receive trophies.





- 16.4 Trophies will be awarded to the overall regatta 1st place in each division for IRC Handicaps. 5 IRC entries are required for a division to receive IRC trophies.
- 16.5 A trophy will be awarded to the overall regatta champion.
- 16.6 Pennants will be awarded to the KIC 1st, 2nd and 3rd places in the feeder race.
- 16.7 A trophy will be awarded to the first-place getter in the KIC race.
- 16.8 The main regatta presentation will be held after lunch on the 30<sup>th</sup> December upon completion of the mornings racing.

### 17. Disclaimer of Liability

17.1 Competitors participate in the regatta entirely at their own risk. See RRS rule 3 Decision to Race. The OA, its associates and appointees will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

#### 18. Insurance

18.1 Each participating boat shall be insured with valid third-party insurance with a minimum cover of \$10 million per incident or equivalent. By taking part in the regatta owners are deemed to have made a declaration that they have such cover.

#### 19. Facilities

- 19.1 Available facilities include:
  - (a) Galley, bar and lounge facilities at the Clubhouse.
  - (b) Hot showers at the Clubhouse and Point Peron Hardstand.
  - (c) Ferry service between moored yachts to the Val Street Jetty.
  - (d) Dinghy Storage at Point Peron Hardstand.
  - (e) Moorings available at the TCYC mooring area.
- 19.2 Moorings will be allocated by the OA to each yacht following their mooring request on the nomination form. A mooring chart will be included in the Skippers Pack and on the website.
